Dear Ms. Downey:

On September 22, 2016, Niagara Mohawk Power Corporation (Niagara Mohawk) submitted a Notice of Cancellation of a Cost Reimbursement Agreement (Reimbursement Agreement) with the New York Power Authority.¹ The Reimbursement Agreement is being cancelled because the project described in the Reimbursement Agreement has ended and all invoicing under the agreement has been completed.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. §375.307, your submittal is accepted for filing, effective November 22, 2016, as requested.

The filing was noticed on September 22, 2016, with comments, interventions, and protests due on or before October 13, 2016. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2016)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
