Reference: Large Generator Interconnection Agreement

On August 21, 2019, the New York Independent System Operator, Inc. (NYISO) and Niagara Mohawk Power Corporation d/b/a National Grid (National Grid) (Joint Filing Parties) submitted for filing a Large Generator Interconnection Agreement entered into among NYISO, National Grid, and Ball Hill Wind Energy, LLC (Ball Hill).¹ The Joint Filing Parties state that the filing contains non-conforming language, including limited operation of the Ball Hill facility pending certain upgrades, and ministerial changes.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307 (2017), your submittal is accepted for filing, effective July 31, 2019, as requested.

The filing was noticed on August 21, 2019, with comments, interventions, and protests due on or before September 11, 2019. interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties. Arkwright filed comments in support.

This acceptance for filing shall not be construed as constituting approval of the referenced filing or of any rate, charge, classification, or any rule, regulation, or practice affecting such rate or service contained in your filing; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders that have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against NYISO or National Grid.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
