On April 17, 2020, you filed, on behalf of Niagara Mohawk Power Corporation (Niagara Mohawk), an Engineering & Procurement Agreement (E&P Agreement) between Niagara Mohawk and New York Transco, LLC (NY Transco), designated as Service Agreement No. 2531 under New York Independent System Operator, Inc.'s Open Access Transmission Tariff.¹ You state that the E&P Agreement is an undisputed agreement to facilitate the performance of certain work that NY Transco has requested Niagara Mohawk to do with respect to the mitigation of the impact of the New York Energy Solution Project on Niagara Mohawk's transmission system.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, your submittal is accepted for filing, effective March 18, 2020, as requested.

The filing was noticed on April 17, 2020, with comments, interventions, and protests due on or before May 8, 2020. Pursuant to Rule 214 (18 C.F.R. § 385.214), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
