Reference: Fast-Start Resource Pricing Tariff Amendment

On December 7, 2020, New York Independent System Operator, Inc. (NYISO) filed revisions to its Market Administration and Control Area Services Tariff to amend its Fast-Start Resource pricing revisions, which the Commission accepted in Docket No. ER20-659-000.¹ NYISO states that the proposed revisions specify how NYISO will determine a Fast-Start Resource's start-up cost for consideration in the Real-Time Market software.²

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, your submittal is accepted for filing, effective December 15, 2020, as requested.

The filing was noticed on December 7, 2020, with comments, interventions, and protests due on or before December 28, 2020. Pursuant to Rule 214 (18 C.F.R. § 385.214), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
