On January 15, 2021, New York Independent System Operator, Inc. (NYISO) submitted, on behalf of NextEra Energy Transmission New York, Inc. (NEET New York), revisions to the NYISO Open Access Transmission Tariff (OATT)<sup>1</sup> to (i) incorporate the formula rate template and implementation protocols previously approved by the Commission for NEET New York with minor corrections; and (ii) incorporate the previously approved cost allocation for NEET New York's Empire State Line Project, as updated.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, your submittal is accepted for filing, effective March 17, 2021, as requested.

The filing was noticed on January 15, 2021, with comments, interventions, and protests due on or before February 5, 2021. Pursuant to Rule 214 (18 C.F.R. § 385.214), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
