Reference: Compliance Filing Establishing Effective Date for Energy Storage Resource Participation Model Revisions

On August 12, 2020, in accordance with the requirements of the Commission's June 17, 2020 order in this proceeding,¹ the New York Independent System Operator, Inc. (NYISO) filed revisions to its Market Administration and Control Area Services Tariff to reflect August 26, 2020 as the effective date for revisions related to its Energy Storage Resource participation model.² The compliance filing satisfactorily complies with the Commission's requirements.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. §375.307, your submittal is accepted for filing, effective August 26, 2020, as requested.

The filing was noticed on August 13, 2020, with comments, interventions, and protests due on or before September 2, 2020. Pursuant to Rule 214 (18 C.F.R. §

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
