On October 20, 2022, as amended on July 14, 2023, New York Independent System Operator, Inc. (NYISO) submitted revisions to sections 2.18 and 23.2 of the Market Administration and Control Area Services Tariff (Services Tariff)¹ to correct the tariff records associated with NYISO's September 3, 2020 filing in compliance with the directives in a August 3, 2020 Commission order.² NYISO requested that the filings be accepted effective dates August 26, 2020, and September 8, 2020, respectively.

Pursuant to authority delegated to the Director, Division of Electric Power Regulation – East under 18 C.F.R. § 375.307, the submittals are accepted for filing, effective August 26, 2020 and September 8, 2020, respectively, as requested.³

The filings were publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission's regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.
