Dear Ms. Lampi:

New York Independent System Operator, Inc.'s (NYISO) submittals are accepted for filing effective May 31, 2010, as requested and as designated.¹

On March 31, 2010, as amended on April 16, 2010 and on April 27, 2010, NYISO filed tariff revisions to its Open Access Transmission Tariff (OATT) and its Market Services Tariff (Services Tariff) to revise provisions concerning the Transmission Congestion Contracts (TCC) market. NYISO states that the revised tariff sheets reorganize and clarify tariff provisions that govern the TCC market and eliminate redundancy between the OATT and Services Tariff. NYISO states that the revised tariff sheets make no substantive changes to tariff provisions or current practices concerning the TCC market. The revised tariff sheets revise provisions in Section 1, Attachment M and Attachment N of the OATT. NYISO has also proposed changes to Section 7 and Attachment B of the Services Tariff.

Notice of the filings was issued on April 1, 2010, April 19, 2010, and April 28,

2010 with comments due on April 21, 2010, April 26, 2010 and May 7, 2010 respectively. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2009)), all timely filed motions to intervene and any motion to intervene out-of-time filed before the issuance date of this order are granted. Granting late intervention at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties. No protests or adverse comments were filed.

This action is taken pursuant to the authority delegated to the Director, Division of Electric Power Regulation - East, under 18 C.F.R. § 375.307.

This acceptance for filing shall not be construed as constituting approval of the reference filing or of any rate, charge, classification, or any rule, regulation, or practice affecting such rate or service contained in your filing; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or order which have been or any which may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against your company.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
