# Re: Docket No. ER16-1751-000, New York Independent System Operator – Notice of Effective Date

Dear Secretary Bose:

On May 20, 2016, the New York Independent System Operator, Inc. ("NYISO") filed proposed revisions to its Market Administration and Control Area Services Tariff ("Services Tariff") to implement certain enhancements to its ICAP Demand Curve reset ("DCR") process ("DCR Enhancements Filing").<sup>1</sup> On July 18, 2016, the Federal Energy Regulatory Commission ("Commission") accepted the proposed revisions ("July 18 Order").<sup>2</sup> The majority of the tariff revisions became effective on July 19, 2016, except for the revisions to Attachment H of the Services Tariff.
