**Notice of Cancellation of Service Agreement with Tug Hill Energy, Inc. and
Request for Waiver of Notice Requirement**

Dear Secretary Bose:

Pursuant to Section 35.15 of the Federal Energy Regulatory Commission's ("Commission") regulations,¹ Niagara Mohawk Power Corporation ("Niagara Mohawk") submits for Commission acceptance this Notice of Cancellation of the Amended and Restated Interconnection Agreement between Niagara Mohawk and Tug Hill Energy, Inc. ("Tug Hill") ("Service Agreement").² The Service Agreement has terminated pursuant to a notice provided by Tug Hill. Niagara Mohawk respectfully requests that the Commission accept this Notice of Cancellation effective as of the termination date requested by Tug Hill, *i.e.*, August 24, 2017.

I. Background and Justification for Cancellation

The Service Agreement went into effect on October 12, 2010.³ According to its terms, the Service Agreement may be terminated upon the provision of written notice by Tug Hill to Niagara Mohawk at least 20 business days in advance of the termination date.⁴ On July 27, 2017, Tug Hill provided such notice to Niagara Mohawk to terminate the Service Agreement effective August 24, 2017.⁵

II. Effective Date and Request for Waiver of Notice Requirement

Niagara Mohawk respectfully requests waiver of the 60-day prior notification requirement contained in Section 35.15 of the Commission's regulations and that the Commission accept this Notice of Cancellation effective August 24, 2017.⁶ The Service Agreement terminated as of that date pursuant to the notice that Tug Hill provided to Niagara Mohawk as described above. Therefore, good cause exists to cancel the Service Agreement as of the requested effective date.
