## Dear Secretary Bose:

In accordance with the requirements of the Federal Energy Regulatory Commission's ("Commission's") January 4, 2019 *Order on Compliance*<sup>1</sup> in this proceeding, the New York Independent System Operator, Inc. ("NYISO") submits this filing to provide notice of an expected effective date of June 11, 2019 for the tariff amendments to implement the NYISO's Operator-Initiated Commitment Report.<sup>2</sup>

The *Order on Compliance* accepted the NYISO's proposal for a flexible effective date between June 1 and June 20, 2019 to implement the Operator-Initiated Commitment Report Tariff revisions. The NYISO hereby notifies the Commission and its Market Participants that it intends to implement the Operator-Initiated Commitment Report in its software and Tariffs on June 11, 2019. Due to the nature of the software implementation, Operator-Initiated Commitments that occur before the new software is deployed to production on June 11 will appear on the existing Operational Announcements report. Operator-Initiated Commitments and modifications to previously posted commitments that occur after the software deployment will appear on the new Operator-Initiated Commitment Report.
