Dear Ms. Bose:

In its June 8, 2023 order in the above-captioned proceeding (“Order”),¹ the Commission granted Homer Solar Energy Center, LLC (“Homer”) a waiver of certain requirements in the New York Independent System Operator, Inc.’s (“NYISO”) Open Access Transmission Tariff (“OATT”), subject to certain conditions. In particular, the Commission permitted Homer to extend the Commercial Operation Date (“COD”) for its Homer Solar Energy Center project (NYISO Queue Position No. 276) until April 30, 2026, subject to two conditions. First, Homer was required to promptly provide to the NYISO and Niagara Mohawk Power Corporation d/b/a National Grid (“National Grid”), the Connecting Transmission Owner, a revised, detailed milestone schedule for the draft Large Generator Interconnection Agreement (“LGIA”) for this project that would support the requested COD.² Second, Homer was required to either execute an LGIA with Niagara Mohawk and NYISO or request that the NYISO file an unexecuted LGIA with the Commission within 30 calendar days of the Order.³

The NYISO provides this notice to the Commission for informational purposes to confirm that Homer timely satisfied these two conditions and that the NYISO, National Grid, and Homer fully executed an LGIA for the Homer Solar Energy Center project on July 6, 2023 with OATT Service Agreement No. 2787. As this agreement conforms with the NYISO’s *pro forma* LGIA set forth in Attachment X of the NYISO OATT, the NYISO will report this agreement with its next Electric Quarterly Report.
