Re: *New York Independent System Operator, Inc.*, Notice Establishing Effective Date for Tariff Revisions Developed to Enhance Market Participation by Co-located Storage Resources; Docket No. ER24-2133-000

Dear Secretary Reese,

Consistent with the New York Independent System Operator, Inc.'s ("NYISO's") May 29, 2024 Federal Power Act Section 205<sup>1</sup> filing in Docket No. ER24-2133-000 (the "HSR/CSR Filing"), and the Letter Order issued pursuant to delegated authority on July 23, 2024 accepting the NYISO's proposed Tariff revisions,<sup>2</sup> the NYISO submits this notice informing the Federal Energy Regulatory Commission ("Commission") and its stakeholders that it intends to make the Tariff revisions that expand the range of resource types that are eligible to participate in the NYISO's markets as Co-located Storage Resources ("CSR") effective on December 3, 2024.<sup>3</sup> The CSR Tariff revisions that will become effective on December 3, 2024 are set forth in Attachments V through VIII to the HSR/CSR Filing.

The NYISO has determined that three of the Tariff sections it submitted with the HSR/CSR Filing need to be conformed to address subsequent Commission decisions in other Dockets, and the timing of the NYISO's implementation of those accepted Tariff revisions. None of the conforming changes relate to Tariff revisions that were proposed for the Commission's consideration in the HSR/CSR Filing. Instead, they are changes that were proposed and accepted in Docket No. ER24-1655 (addressing enhancements to financial transaction capabilities and improvements to Fast-Start Resource schedules), and in Docket No. ER24-2096 (addressing accreditation of resources in the capacity market).

<sup>3</sup> There were three different effective dates for the Tariff revisions proposed in the NYISO's May 29, 2024 filing in the above Docket. The first set of Tariff revisions became effective on July 29, 2024. The NYISO requested permission for the CSR Tariff revisions to take effect on a date between October 1 and December 31, 2024. The final set of Tariff revisions, implementing Hybrid Storage Resources in the NYISO's markets, was proposed to become effective in the second half of 2025.

Attachment A to this Effective Date Notice provides redlines of Market Services Tariff Sections 2.3 and 5.12 that incorporate changes that were accepted by the Commission and made effective in Docket No. ER24-2096 after the NYISO submitted its HSR/CSR Filing. Attachment A also includes a redline of Section 17.1 of the Market Services Tariff that removes changes that the NYISO proposed and the Commission accepted in Docket No. ER24-1655, but which the NYISO will not make effective until after December 3, 2024.<sup>4</sup>

**I. Documents Submitted**

Attachment A to this Effective Date Notice contains the conforming revisions to Market Services Tariff Sections 2.3, 5.12 and 17.1 described above.

**II. Notice of Effective Date for Tariff Revisions Expanding Range of Resource Types that May Participate as Co-located Storage Resources**

In compliance with the Letter Order, the NYISO hereby provides notice that it intends to implement the accepted revisions implementing the Tariff revisions set forth in Attachments V through VIII to the HSR/CSR Filing on December 3, 2024.

Submitting this notice now complies with the directive in the Letter Order that the NYISO provide at least two weeks prior notice of the actual effective date for the Tariff revisions accepted in this proceeding.

**III. Service**

The NYISO will send an electronic copy of this filing to the official representative of each party to this proceeding, to the New York Public Service Commission, and to the New Jersey Board of Public Utilities. In addition, a complete copy of this filing will be posted on the NYISO's website at [www.nyiso.com](http://www.nyiso.com), and the NYISO will send an electronic link to this filing to the official representative of each of its customers and to each participant on its stakeholder committees.
