On April 8, 2025, the New York Independent System Operator, Inc. (“NYISO”) filed with the Federal Energy Regulatory Commission (“Commission”), an Executed Engineering, Procurement, and Construction Agreement (“EPC Agreement”) in connection with the Cider Solar Project (NYISO Queue Position No. 811) (“Cider Solar Project”) for Affected System Upgrade Facilities on NextEra Energy Transmission New York Inc.’s system. The EPC Agreement is designated as Service Agreement No. 2893 under the NYISO’s Open Access Transmission Tariff.

The NYISO submits this filing to supplement the record to correct the signature pages submitted as Attachment III to the April 8 filing, which inadvertently included the NYISO’s signature page from the interconnection agreement for the Cider Solar Project in place of its signature page for the EPC Agreement. The NYISO supplements the record to replace Attachment III with the correct signature pages.
