Opening of Engagement Period for Relevant State Entities Regarding Cost Allocation Methodology for Long-Term Regional Transmission Facilities

November 25, 2024

As required by the Federal Energy Regulatory Commission's Order No. 1920, *Building for the Future Through Electric Regional Transmission Planning and Cost Allocation*,¹ the New York Independent System Operator, Inc. ("NYISO") hereby commences a six-month Engagement Period to provide a forum to seek to develop with Relevant State Entities within its planning region the cost allocation methodology(ies) for Long-Term Regional Transmission Facilities selected in the NYISO's transmission planning process. The NYISO provides below details concerning the Engagement Period and forum for its discussions with the Relevant State Entities.

As established in Order No. 1920, "Relevant State Entities" include:

any state entity responsible for electric utility regulation or siting electric transmission facilities within the state or portion of a state located in the transmission planning region, including any state entity as may be designated for the purpose by the law of such state.²

State entities that meet this definition are encouraged to attend the forums (as identified below) during the Engagement Period. To participate in this process, please contact to the NYISO's contact included below and provide the name of your state entity and point of contact. In addition, as required by Order No. 1920, the NYISO also establishes below the deadline for the Relevant State Entities to communicate to the NYISO whether they agree on the cost allocation method for Long-Term Regional Transmission Facilities.

Please note that the NYISO will review any agreement among the Relevant State Entities on the cost allocation method for Long-Term Regional Transmission Facilities with stakeholders are part of its stakeholder process related to the NYISO's compliance with Order No. 1920.
