Re: Docket No. EL12-98-000, Compliance with Revised Protective Order

Dear Ms. Bose:

On April 4, 2014, the Commission by Letter Order granted Brookfield Energy Marketing's ("Brookfield") proposed modifications to the Protective Order that the Commission issued in this proceeding on January 14, 2014 ("Letter Order"). According to the terms of the modified Protective Order, individuals that qualify as Competitive Duty Personnel must sign a separate Non-Disclosure Certificate that certifies their understanding that they cannot access Highly Sensitive Protected Material. The Commission found "that the proposed modifications to the Protective Order are limited in scope and tailored to meet Brookfield's concern that information specific to Linden VFT could be disaggregated and could cause competitive harm." The NYISO has confirmed that, as of the date of this filing, none of the Reviewing Representatives in this proceeding are Competitive Duty Personnel. Therefore no existing Reviewing Representative is required to sign the separate Non-Disclosure Certificate for Competitive Duty Personnel required by the Letter Order.

Brookfield also specifically requested that the NYISO re-designate the Linden VFT Data as Highly Sensitive Protected Material. By granting Brookfield's motion the Letter Order accepted this request. Accordingly, the NYISO has re-designated and re-labeled the Linden VFT Data as Highly Sensitive Protected Material and requests that the Commission replace the Confidential Attachments A and C that were originally included in the NYISO's February 21, 2014 *Initial Compliance Filing* in this proceeding with the new attached Confidential Attachments A and C. The only changes to these attachments are to change their designation from Protected Material to Highly Sensitive Protected Material.²

² The Letter Order does not require any change in the classification of the Highly Sensitive Protected Material that was included with the NYISO's March 31, 2014 *Request for Leave to Answer and Answer* because that filing does not include any Linden VFT Data.

The NYISO is sending the re-designated Confidential Attachments A and C to the approved Reviewing Representatives, who received the original Confidential Attachments A and C on February 21, with one exception, and is requesting that the Reviewing Representatives return to the NYISO or destroy the original Confidential Attachments A and C.³

The exception is Mr. Jeffrey Woods, Senior Vice President of PowerBridge. Mr. Woods is not eligible under Section 10(b)(1) - (6) of the revised Protective Order to be a Reviewing Representative of Highly Sensitive Protected Material. Thus, although Mr. Woods was appropriately provided the aggregated Linden VFT Data that was in Attachments A and C when it was designated as Protected Material, it appears that Mr. Woods cannot receive, and should no longer retain it, now that it is designated as Highly Sensitive Protected Material unless he becomes eligible under Sections 10(b)(7) or (8). The NYISO is therefore requesting that Mr. Woods surrender the Linden VFT Data to his outside counsel until such time as he may become eligible under Sections 10(b)(7) or (8).

This filing, without the Confidential Attachments, will be posted on the NYISO's website at www.nyiso.com. In addition, the NYISO will e-mail an electronic link to this filing to the official representative of each party to this proceeding, to each of its customers, to each participant on its stakeholder committees, to the New York Public Service Commission, and to the New Jersey Board of Public Utilities.
