## Dear Secretary Bose

On April 11, 2014, as amended on May 19, 2014, TC Ravenswood, LLC ("TC Ravenswood") initiated Docket No. ER14-1711 by filing a proposed rate schedule to provide Reliability Oil Burn Service. On April 30, 2014, the New York Independent System Operator, Inc. ("NYISO") initiated Docket No. ER14-1822 by filing an unexecuted Minimum Oil Burn Agreement between the NYISO and TC Ravenswood. Both matters are pending before the Commission for decision.

TC Ravenswood, the NYISO, the New York Public Service Commission ("NYPSC") and Consolidated Edison Company of New York, Inc. ("Con Edison") have had some preliminary discussions with the goal of settling both dockets. TC Ravenswood and NYISO believe that the goal of achieving a settlement that will be supported, or not opposed, by all parties to the two proceedings, will be enhanced if the Commission temporarily defers issuing a ruling in either docket. Therefore, TC Ravenswood and the NYISO jointly request that the Commission hold each proceeding in abeyance until August 21, 2014. It is TC Ravenswood's and the NYISO's intention to bring all parties to the two dockets into the settlement discussions with the goal of filing an offer of settlement prior to that date. In the event the parties have not filed an offer of settlement by August 21, 2014, TC Ravenswood and the NYISO will either advise the Commission that additional time is needed to resolve the issues and request further deferral of Commission action on the two filings, or advise the Commission that the parties were unable to resolve their disputes and Commission action on the two filings is required.
