Re: New York Independent System Operator, Inc., Docket ER18-604-000; Bid Restriction Waiver Informational Filing

Dear Ms. Bose:

In accordance with paragraph 15 and ordering paragraph "B" of the Federal Energy Regulatory Commission's ("Commission's") January 12, 2018 *Order Granting Waiver* ("January Order"),¹ the New York Independent System Operator, Inc. ("NYISO") submits herein the information required by the Commission.

On January 4, 2018, the NYISO requested a limited waiver of the Bid Restriction<sup>2</sup> set forth in Sections 21.4 and 21.5.1 of its Market Administration and Control Area Services Tariff ("Services Tariff"). The Commission's January Order granted the NYISO's limited waiver request for the period of January 4, 2018 (January 5, 2018 for the NYISO's Day-Ahead Market) through February 28, 2014 ("Waiver Period") and directed the NYISO to

submit an informational filing by March 28, 2018 that identifies: (1) the total amount of energy that received compensation pursuant to the terms of the instant waiver; (2) the demonstrated costs of such energy in total and on a unit cost basis; and (3) information detailing requests for compensation pursuant to the instant waiver that were rejected by NYISO and the reason for its rejection.<sup>3</sup>

The NYISO responds to each of the Commission's questions below.

Information Request: (1) Identify the total amount of energy that received compensation pursuant to the terms of the instant waiver.

NYISO Response: No energy received compensation pursuant to the terms of the waiver.

Information Request: (2) Identify the demonstrated costs of such energy in total and on a unit cost basis.

NYISO Response: There are no costs to report.

Information Request: (3) Provide information detailing requests for compensation pursuant to the instant waiver that were rejected by NYISO and the reason for each rejection.

NYISO Response: The NYISO did not receive any requests for compensation pursuant to the waiver. Although there were Generators that faced expected costs in excess of \$1,000/MWh over the waiver period, the NYISO did not commit any resources with expected costs in excess of \$1,000/MWh.

The NYISO will send an electronic link to this filing to the official service list in Docket No. ER18-604-000 and representative of each party to this proceeding, to the official representative of each of its customers, to each participant on its stakeholder committees, to the New York Public Service Commission, and to the New Jersey Board of Public Utilities.
