In compliance with Paragraph 2 of the Federal Energy Regulatory Commission's ("Commission's") August 1, 2012 Order<sup>1</sup> in this docket, and pursuant to the May 30, 2012 filing by the New York Independent System Operator, Inc.("NYISO") creating a new NonHistoric Fixed Price Transmission Congestion Contract (TCC),<sup>2</sup> the NYISO hereby notifies the Commission that it will be implementing the tariff changes identified in the May 30 filing and accepted in the August 1 Order on October 24, 2012.
