> Re: Docket No. ER17-1629-000, Niagara Mohawk Power Corporation d/b/a National Grid – Ministerial Correction to Proposed Tariff Revisions

Dear Secretary Bose:

On May 19, 2017, the New York Independent System Operator, Inc. ("NYISO"), in its role as Tariff Administrator, submitted a filing on behalf of Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid") in the above referenced docket proposing the establishment of a new Rate Schedule 17 to the NYISO Open Access Transmission Tariff ("OATT"). After submission of the initial filing, the NYISO identified an inadvertent administrative error with respect to the manner in which the proposed revisions to the OATT were submitted for purposes of the Federal Energy Regulatory Commission ("FERC" or "Commission") eTariff system. The NYISO misidentified the location of the new Rate Schedule within its OATT.

The NYISO hereby submits this filing to correct this ministerial error and properly identify the location of National Grid's proposed new rate schedule as following Section 6.16 of the OATT within FERC's eTariff system. There are no changes to the May 19, 2017 filing letter or National Grid's proposed Rate Schedule 17.

I. Documents Submitted

The NYISO respectfully submits the following document with this filing letter:

1. A clean version of the proposed Rate Schedule 17 as filed on May 19, 2017 ("Attachment I"); and

2. A blacklined version of the proposed Rate Schedule 17 as filed on May 19, 2017 ("Attachment II").

II. Proposed Effective Date

In its May 19, 2017 filing, National Grid requested an effective date of July 19, 2017 (*i.e.*, 61 days after filing). In addition, the Combined Notice of Filings #1 issued by the Commission on May 19, 2017 established a comment deadline of 5 p.m. ET on June 9, 2017 with respect to National Grid's May 19, 2017 filing. Because this filing merely corrects a ministerial error in FERC's eTariff system and has no substantive impact on National Grid's May 19, 2017 filing letter or the proposed tariff revisions submitted therewith, it is respectfully requested that: (i) National Grid's previously requested effective date (*i.e.*, July 19, 2017) be retained; and (ii) the Commission's previously established comment deadline remain unaltered.

III. Service

The NYISO will send an electronic link to this filing to: (i) the official representative of each party to this proceeding; (ii) the official representative of each of its customers; (iii) each participant on its stakeholder committees; (iv) the New York State Public Service Commission; and (v) the New Jersey Board of Public Utilities. In addition, the complete filing will be posted on the NYISO's website at www.nyiso.com.

IV. Conclusion

The NYISO respectfully requests that the Commission accept this ministerial correction.
