Re: New York Independent System Operator, Inc., Errata to properly locate a tariff section within the NYISO's and Commission's database; Docket No. ER20-1105-000

## Dear Secretary Bose:

The New York Independent System Operator, Inc. ("NYISO") submits this ministerial errata to its February 27, 2020 Short-Term Reliability Process filing in Docket No. ER20-1105-000 ("STRP Filing"). The STRP Filing was proposed to better integrate the Generator Deactivation Process with the rest of the NYISO's Reliability Planning Process. The Commission's April 30, 2020 Order in the above Docket accepted the NYISO's filing, effective May 1, 2020. <sup>2</sup>

It has come to the NYISO's attention that when the eTariff records included with the STRP filing were designated, Attachment P (Section 22) of the NYISO's Open Access Transmission Tariff ("OATT"), which holds Record ID 354 in "NYISO Tariffs," was inadvertently inserted into the record placeholder established for Appendix 1 to Attachment P (Record ID 468). As a result, the version of Attachment P that was filed on February 22, 2020 overwrote Appendix 1 to Attachment P that was on file with the Commission instead of being filed in its designated position in eTariff. This errata filing proposes to correct the relevant tariff records.

> 3. The version of the NYISO's OATT Appendix 1 to Attachment P, that became effective April 1, 2016, to restore it to Record ID 468 in the database ("Attachment II").

#### II. **Errata**

As outlined above, the NYISO submits OATT Attachment P, that includes the revisions that were accepted in the STRP Order, and Appendix 1 to Attachment P to restore them to their correct positions in eTariff. There are no substantive revisions proposed in this errata filing and the incorrectly located tariff sections had no material bearing on the language the Commission accepted in the STRP Order.

In addition, the NYISO will e-mail an electronic link to this filing to the official representative of each party to this proceeding, to each of its customers, to each participant on its stakeholder committees, to the New York Public Service Commission, and to the New Jersey Board of Public Utilities.
