Re: New York Independent System Operator, Inc., Errata to Second Compliance Filing to Establish Self Supply Exemption, Docket No. ER16-1404-005

Dear Secretary Bose:

Yesterday, the New York Independent System Operator, Inc. (“NYISO”) submitted, in the above-captioned docket, its Second Compliance Filing to Establish Self Supply Exemption (“Second SSE Compliance Filing”). After it made the Second SSE Compliance Filing, the NYISO discovered inadvertent errors in the tariff sheets that were submitted with the filing. The NYISO respectfully submits the enclosed errata filing to correct those errors.¹

I. Errata

In Section 23.4.5.7.14 submitted with the Second SSE Compliance Filing, the NYISO discovered two errors to be corrected. First, the version of Section 23.4.5.7.14 submitted with the Second SSE Compliance Filing contains references to the term “Colocated Storage Resource” or “CSR.” That term is part of a stakeholder-approved market design, but it has not yet been filed with the Commission and should not have been added to Section 23.4.5.7.14. Accordingly, the errata version of Section 23.4.5.7.14 submitted herein deletes the references to “CSR.”

¹ The NYISO attempted to submit the Second SSE Compliance Filing before the 5:00 PM filing deadline on December 21, 2020. The Second SSE Compliance Filing included a number of re-filed and conforming tariff revisions to address issues that had arisen in the four years since the NYISO’s last SSE-related filing. *See* Second SSE Compliance Filing at Section III.B.5 and Attachments III and IV. Due to unexpected complications, however, the processing of the filing through the eFiling system took longer than anticipated, and the system deemed the filing complete twelve seconds past 5:00, assigning it a December 22, 2020 date. To the extent that the Commission deems the Second SSE Compliance Filing to have been untimely submitted, the NYISO respectfully requests that it excuse that untimeliness. Parties were served copies of the filing shortly after 5:00 PM on December 21 and a twelve second delay in the eFiling process will not prejudice any party or interest. Excusing any untimeliness would also be consistent with the procedural waivers that the Commission has granted due to the COVID-19 pandemic. *See Supplemental Notice Waiving Regulations*, Docket NO. AD20-11-000 (August 20, 2020) (extending waivers through January 29, 2021).

The second correction involves the new language in Section 23.4.5.7.14 reflecting the process that the NYISO will use to revoke a Self Supply Exemption. That language erroneously references the Renewable Exemption, rather than the Self Supply Exemption. Accordingly, the enclosed errata tariff sheets replace the term Renewable with Self Supply in this part of Section 23.4.5.7.14.

In addition to the corrections to Section 23.4.5.7.14, the NYISO also discovered that Section 30.4 contains an erroneous effective date. The NYISO has corrected Section 30.4 to reflect, for language submitted in that provision on April 13, 2016, the effective date proposed in the Second SSE Compliance Filing (*i.e.*, February 20, 2021).

1. A redlined version of the NYISO's Services Tariff Section 23.4.5.7.14 to replace the version of Section 23.4.5.7.14 in the Second SSE Compliance Filing ("Attachment I");
2. A clean version of the replacement version of Section 23.4.5.7.14 ("Attachment II"); and
3. A clean version of the NYISO's Services Tariff Section 30.4 showing a corrected proposed effective date of February 20, 2021 ("Attachment III").

III. Service

This errata to the Second SSE Compliance Filing will be posted on the NYISO's website at www.nyiso.com. In addition, the NYISO will e-mail an electronic link to this filing to the official representative of each party to this proceeding, to each of its customers, to each participant on its stakeholder committees, to the New York Public Service Commission, and to the New Jersey Board of Public Utilities.

IV. Conclusion

The New York Independent System Operator, Inc. respectfully requests that the Commission accept for filing the proposed Services Tariff corrections that are attached hereto, with an effective date of February 20, 2021, the same effective date requested for the Second SSE Compliance Filing.
