## Re: LS Power Grid New York Corporation I Docket No. ER20-716-001 Offer of Settlement

Dear Ms. Bose:

Pursuant to Rule 602 of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission, 18 C.F.R. § 385.602 (2017), the New York Independent System Operator, Inc. ("NYISO") as administrator of the NYISO Open Access Transmission Tariff ("Tariff"), submits via eTariff on behalf of LS Power Grid New York Corporation I ("LSPGNY") and the settling parties an Offer of Settlement ("Settlement"). The Settlement, if approved by the Commission, will resolve all issues set for hearing in this proceeding<sup>1</sup> without the need for any further proceedings regarding those issues. The Settlement is not opposed by any active party to the proceeding.

In addition to the issues addressed in the Offer of Settlement, the tariff sheets revise certain NYISO numbering protocols that changed after the filing of LSPGNY's original Tariff filing.<sup>2</sup>
