Re: New York Independent System Operator, Inc.; Notice of Effective Date for Services Tariff Revisions, Docket No. ER21-486-00

Dear Secretary Bose:

On November 25, 2020, the New York Independent System Operator, Inc. ("NYISO") filed proposed revisions to its Market Administration and Control Area Services Tariff ("Services Tariff") and Open Access Transmission Tariff ("OATT") to implement certain enhancements to its credit requirements for Transmission Congestion Contracts ("TCCs"). On January 12, 2021, the Federal Energy Regulatory Commission ("Commission") issued an order accepting the NYISO's proposal ("January 12 Order").

The January 12 Order directed the NYISO to submit a subsequent compliance filing(s) to provide notice of the expected effective date(s) for the proposed tariff revisions "no later than 14 days prior to the date on which the revisions will become effective." On July 23, 2021, the NYISO submitted a compliance filing to provide notice of an August 6, 2021 effective date for the revisions to the OATT accepted by the Commission in the January 12 Order ("July 23 Notice"). The July 23 Notice noted that the NYISO would submit a subsequent filing to provide notice of the expected effective date for the revisions to Attachment K of the Services Tariff accepted by the January 12 Order.

The NYISO submits this filing to provide notice of the expected effective date for the revisions to Attachment K of the Services Tariff accepted by the January 12 Order.⁵
