On August 17, 2021, the New York Independent System Operator, Inc. ("NYISO") submitted on behalf of LS Power Grid New York Corporation I ("LSPGNY") a compliance filing to comply with the Commission's order of June 17, 2021 accepting the Settlement in the referenced Docket.
