Dear Secretary Bose:

On April 6, 2022, the New York Independent System Operator, Inc. ("NYISO") submitted, in the above-captioned docket, its Compliance Filing pertaining to certain North American Energy Standards Board ("NAESB") Wholesale Electric Quadrant ("WEQ") business practice standards as set forth in Commission Order 676-I and subsequent Errata Notice (hereinafter, "NAESB Filing"). After submitting its NAESB Filing, the NYISO discovered ministerial errors associated with the tariff sections that were submitted with the filing. The NYISO respectfully submits the enclosed errata to correct those errors.

I. Errata

The NYISO proposes the following revisions to both the Open Access Transmission Tariff ("OATT") and Market Administration and Control Area Services Tariff ("Services Tariff") sections:

- The list of NAESB Standards incorporated by reference or for which the NYISO was
 granted waivers was reformatted to reflect the numbering set forth in the Errata
 Notice issued by the Commission in this matter on March 3, 2020; and
- The identification of NAESB Standards WEQ-001 and WEQ-003 is updated to reflect the nomenclature in the Commission's March 3, 2020 Errata Notice.

Additionally, the NYISO inadvertently uploaded OATT Section 2.17 to the eTariff system in place of—and incorrectly named as—Services Tariff Section 5.1. The NYISO has fixed this error with this filing, and also will withdraw from eTariff the MST and OATT sections provided for information only with the changes sought with a June 2, 2022 effective date.

II. Documents Submitted with this Filing Letter

- 2. A clean version of the replacement version of Section 5.1 incorporating the changes described above ("Attachment II");
- 3. A redlined version of the NYISO's OATT Section 2.17 reflecting the changes described above ("Attachment III"); and
- 4. A clean version of the replacement version of Section 2.17 incorporating the changes described above ("Attachment IV").

III. Service

The NYISO will send an electronic copy of this errata to the NAESB Filing to the official representative of each party to this proceeding, to the New York Public Service Commission, and to the New Jersey Board of Public Utilities. In addition, a complete copy of this filing will be posted on the NYISO's website at www.nyiso.com, and the NYISO will send an electronic link to this filing to the official representative of each of its customers and to each participant on its stakeholder committees.

IV. Conclusion

The NYISO respectfully requests that the Commission accept for filing the proposed Services Tariff and OATT corrections that are attached hereto, with an effective date of 12/31/9998.
