> Re: Notice of Cancellation of Service Agreement No. 2549 to the New York Independent System Operator, Inc.'s Open Access Transmission Tariff, Docket No. ER22-____

Dear Ms. Bose:

Pursuant to Section 205(d) of the Federal Power Act¹ and Sections 35.9 and 35.15 of the Commission's regulations,² the New York Independent System Operator, Inc. ("NYISO") hereby tenders for filing and acceptance a Notice of Cancellation of the Amended and Restated Small Generator Interconnection Agreement for the North Country Solar project (NYISO Queue No. 589) ("Interconnection Agreement") among the NYISO, Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid") as the Connecting Transmission Owner, and Duke Energy Renewables Solar, LLC ("Duke") as the Interconnection Customer.³ The Interconnection Agreement is designated as Service Agreement No. 2549 under the NYISO's Open Access Transmission Tariff ("OATT"). National Grid and Duke have indicated to the NYISO that neither party opposes this filing.

I. <u>Background</u>

The Interconnection Agreement for which the NYISO submits this Notice of Cancellation was initially filed in Docket No. ER20-2749 on August 26, 2020, as Service Agreement No. 2549 and accepted by the Commission.⁴ The Interconnection Agreement provided for Duke to construct a 15 MW solar powered Small Generating Facility that would interconnect to the 46kV bus at National Grid's Boonville Station. The Interconnection

Agreement was subsequently amended and restated by the parties, which later version was filed in Docket No. ER22-2288 and was accepted by the Commission on August 23, 2021.⁵

II. Notice of Cancellation

Article 3.3.1 of the Interconnection Agreement establishes that the Interconnection Customer may terminate the Interconnection Agreement by giving the NYISO and Connecting Transmission Owner 20 Business Days written notice.⁶ Article 3.3 of the Interconnection Agreement further provides that the termination will not be effective until the parties have filed any required notice of termination at the Commission, which notice has been accepted for filing by the Commission.

Pursuant to Article 3.3.1, Duke provided a letter to the NYISO and National Grid dated March 14, 2022 requesting termination of the Interconnection Agreement.⁷ In addition, pursuant to the waiver rules in Article 12.4.2 of the Interconnection Agreement, Duke requested that the NYISO and National Grid agree to waive the 20 Business Days advanced notice period for termination, which the NYISO and National Grid agreed to do.⁸ The NYISO confirmed with National Grid and Duke that there were not any remaining obligations under the Interconnection Agreement, and National Grid confirmed on June 30, 2022, that it had issued the final invoice to Duke under the agreement.

Accordingly, pursuant to Duke's letter of March 14, 2022 and Articles 3.3 and 3.3.1 of the Interconnection Agreement, the NYISO hereby submits this Notice of Cancellation of Service Agreement No. 2549 of the NYISO OATT.

III. <u>Requested Effective Date</u>

The NYISO requests that the Commission waive the sixty-day (60) notice requirement specified in section 35.15 of the Commission's regulations to permit this Notice of Cancellation to be effective as of March 14, 2022.⁹ Good cause exists for granting this effective date. No developers will be harmed by the termination of this Interconnection Agreement. In addition, National Grid has issued Duke the final invoice under the Interconnection Agreement for payment by Duke,¹⁰ and there are no other remaining obligations under the agreement. The
