Dear Ms. Bose:

The New York Independent System Operator, Inc. ("NYISO"), files this letter in response to the Federal Energy Regulatory Commission's Order No. 739, the Final Rule on Promoting Competitive Markets for Capacity Reassignment. Order No. 739 lifted the price cap for all reassignments of electric transmission capacity effective October 1, 2010 and required entities to revise section 23 of their Open Access Transmission Tariff ("OATT") by October 25, 2010.

The NYISO's OATT does not contain the *pro forma* OATT section 23 on capacity reassignments. The NYISO filed to remove section 23 and Attachment A-1 on April 10, 2009 and the Commission accepted the NYISO's filing on June 5, 2009.² The NYISO submits this letter to explain that the NYISO OATT does not have the *pro forma* OATT provisions on capacity reassignments, and therefore no modifications are required.
