**NOTICE OF WITHDRAWAL OF REQUESTS FOR WAIVERS AND EXPEDITED
ACTION OF THE NEW YORK INDEPENDENT SYSTEM OPERATOR, INC.**

In accordance with Rule 216 of the Federal Energy Regulatory Commission’s (“Commission”) Rules of Practice and Procedure, 18 C.F.R. § 385.216 (2022), the New York Independent System Operator, Inc. (“NYISO”), hereby respectfully submits this notice of withdrawal of the *Request for Prospective Tariff Waiver, for Expedited Action, and for Waiver of Comment Period* (“Waiver Request”) that the NYISO submitted November 10, 2022.

The Waiver Request addressed a software problem that threatened the NYISO’s ability to post the results for the December Monthly Auction¹ by the November 10 deadline established by the Market Administration and Control Area Services Tariff (“Services Tariff”). However, the NYISO was ultimately able to calculate valid auction results in time. Those results were posted late in the evening of November 10. The NYISO therefore satisfied the Services Tariff’s requirement that there be at least four business days between the posting of the auction results and November 18, which is when Load Serving Entities are required by tariff to certify the Unforced Capacity that they have procured for the December Obligation Procurement Period. Consequently, there is no longer any need for the relief requested by the Waiver Request.

The NYISO greatly appreciates the Commission’s attention to this matter.

¹ Capitalized terms that are not otherwise defined herein shall have the meaning specified in the NYISO’s Market Administration and Control Area Services Tariff.
