**Notice of Cancellation of Cost Reimbursement Agreement with
Village of Solvay**

Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act (“FPA”)¹ and Section 35.15(a) of the regulations of the Federal Energy Regulatory Commission (the “Commission”),² Niagara Mohawk Power Corporation (“Niagara Mohawk”) hereby submits for Commission acceptance this Notice of Cancellation of the Cost Reimbursement Agreement (“Reimbursement Agreement”) between Niagara Mohawk and the Village of Solvay (“Solvay”).³ Niagara Mohawk requests that the Commission accept this Notice of Cancellation effective as of February 12, 2023, *i.e.*, 61 days after the date of this filing.

I. Background and Reasons for Cancellation

The purpose of the Reimbursement Agreement is to facilitate certain engineering, design, and procurement work that Solvay requested Niagara Mohawk to perform as specified in the Reimbursement Agreement. The Commission accepted Niagara Mohawk’s filing of the Reimbursement Agreement in 2012.⁴
