Independent System Operator, Inc.'s Open Access Transmission Tariff, Docket

Dear Ms. Bose:

Pursuant to Section 205(d) of the Federal Power Act<sup>1</sup> and Sections 35.9 and 35.15 of the Commission's regulations,<sup>2</sup> the New York Independent System Operator, Inc. ("NYISO") hereby tenders for filing and acceptance a Notice of Cancellation of the Second Amended and Restated Large Generator Interconnection Agreement ("Second Amended Agreement") for the Berrians East Replacement project (NYISO Queue Position No. 393) among the NYISO, Consolidated Edison Company of New York, Inc. ("Con Edison"), as the Connecting Transmission Owner, and NRG Berrians East Development LLC ("NRG") as the Developer. The Second Amended Agreement is designated as Service Agreement No. 2535 under the NYISO's Open Access Transmission Tariff ("OATT"). Con Edison and NRG have indicated to the NYISO that neither party opposes this filing.

**I. Background**

NRG owns a generating facility in Astoria, in Queens County, New York that entered commercial operation in 1970 ("Existing Facility"). The Existing Facility was initially owned by Con Edison and was subsequently sold by Con Edison to NRG Energy, Inc., in 1999. There is no pre-existing interconnection agreement for the Existing Facility, which pre-dated the Commission's Order No. 2003 and was not subject to the requirement to enter into an interconnection agreement with the NYISO under the transition rules adopted by the NYISO to implement the Order No. 2003 requirements.

NRG proposed the Berrians East Replacement project to replace twelve gas turbine generators at the Existing Facility, which currently interconnects with Con Edison's 138 kV Astoria East Substation that is part of the New York State Transmission System, with a new Large Generating Facility consisting of one simple cycle unit ("New Facility"). For purposes of this project, the NYISO, Con Edison, and NRG entered into a Large Generating Interconnection

Agreement for the New Facility (“Original Agreement”) with NYISO OATT Service Agreement No. 2535.

The Original Agreement was executed by the parties on June 4, 2020, filed with the Commission on June 18, 2020, and accepted by the Commission on August 14, 2020.<sup>3</sup> The parties subsequently amended and restated the Original Agreement twice – the “First Amended Agreement” - to address changes to the proposed New Facility’s reactive power capability<sup>4</sup> and – the Second Amended Agreement - to update the proposed In-Service Date and Commercial Operation Date of the New Facility.<sup>5</sup>

## **II. Notice of Cancellation**

Article 2.3.1 of the Second Amended Agreement provides that the agreement “may be terminated by the Developer after giving the NYISO and Connecting Transmission Owner ninety (90) Calendar Days advance written notice.” Article 2.3.3 further provides that the termination of the agreement will not be effective: “until the Parties have complied with all Applicable Laws and Regulations applicable to such termination, including the filing with FERC of a notice of termination of this Agreement, which notice has been accepted for filing by FERC.”

On January 10, 2023, NRG provided written notice to the NYISO and Con Edison that it was acting pursuant to Article 2.3.1 to terminate the Second Amended Agreement (“Termination Notice”). This ninety day period was completed on April 10, 2023, and the parties have confirmed that there are no remaining obligations under the Second Amended Agreement.

Therefore, pursuant to Articles 2.3.1 and 2.3.3 of the Second Amended Agreement, the Second Amended Agreement is terminated, subject to the Commission accepting this notice terminating the agreement. Accordingly, the NYISO hereby submits this Notice of Cancellation of Service Agreement No. 2535 of the NYISO OATT for the Commission’s acceptance.

## **III. Requested Effective Date**

The NYISO respectfully requests that the proposed Services Tariff revisions become effective on July 18, 2023 (*i.e.*, the day after the end of the statutory 60-day notice period).
