Re: New York Independent System Operator, Inc., Amendment to Compliance Filing Submitting Technical Corrections to Electronic Tariff Records; Docket No. ER19-467-00\_.

## Dear Secretary Bose:

On September 3, 2020, the New York Independent System Operator, Inc. ("NYISO") submitted to the Federal Energy Regulatory Commission ("Commission") an Errata<sup>1</sup> to its August 12, 2020, Compliance Filing Establishing an Effective Date for its Energy Storage Resource Participation Model (the "September 2020 Filing").<sup>2</sup> The September 2020 Filing remedied inadvertent errors in Market Administration and Control Area Services Tariff ("Services Tariff") Sections 2.18,<sup>3</sup> and 23.2.<sup>4</sup> The September 2020 Filing requested effective dates of August 26, 2020 for Section 2.18 and September 8, 2020 for Section 23.2.

The NYISO submitted a technical correction to the September 2020 Filing on October 20, 2022, amending the September 2020 Filing to remove language proposed in Docket No. ER20-1718-000, *et al.*, from the version of Services Tariff Section 23.2 included in the September 2020 Filing (the October 2022 Filing). The NYISO thereafter became aware of additional corrections necessary in Services Tariff Section 23.2. The NYISO hereby amends Services Tariff Section 23.2.1 to include certain defined terms that were effective as of September 8, 2020, but inadvertently omitted in the October 2022 Filing.

The version of Services Tariff Section 23.2 submitted in this filing adds back the defined terms "Qualified Renewable Exemption Applicant," "Renewable Exemption Applicant," "Renewable Exemption Bank" that were inadvertently omitted in the October 2022 Filing. The NYISO submits this filing to correct the tariff records to accurately reflect the version of Services Tariff Section 23.2 that was effective as of September 8, 2020.
