**Re: Docket No. ER23-1863-00_, New York Independent System Operator, Inc.;
Notice of Effective Date**

Dear Secretary Bose:

On May 11, 2023, the New York Independent System Operator, Inc. (“NYISO”) filed proposed revisions to its Market Administration and Control Area Services Tariff (“Services Tariff”) to implement enhancements to its transmission constraint pricing logic.¹ The Federal Energy Regulatory Commission (“Commission”) issued an order on July 6, 2023 accepting the NYISO’s proposal (“July 6 Order”).²

The July 6 Order directed the NYISO to submit a subsequent filing to specify the effective date for the proposed enhancements.³ The NYISO submits this filing to provide the expected effective date for the tariff revisions accepted by the July 6 Order.

I. Notice of Effective Date

In compliance with the July 6 Order, the NYISO hereby provides notice that it expects to implement the tariff revisions accepted by the Commission on October 10, 2023.⁴ The NYISO respectfully requests that the Commission’s records be updated to reflect such effective date.

⁴ The NYISO expects the tariff revisions will become effective in the Real-Time Market on October 10, 2023 upon deployment and activation of the enabling software enhancements. The revisions will then be incorporated into the execution of the Day-Ahead Market occurring on October 11, 2023 for the October 12, 2023 market day. Should the NYISO determine that it will be unable to implement the tariff revisions on October 10, 2023, it will promptly notify Market Participants and the Commission.

The NYISO will send an electronic copy of this filing to the official representative of each party to this proceeding, the New York State Public Service Commission, and the New Jersey Board of Public Utilities. The NYISO will also send an electronic link to this filing to the official representative of each of its customers, and each participant on its stakeholder committees.
