Dear Secretary Bose:

Central Hudson Gas and Electric Corporation ("Central Hudson" or "Applicant") hereby submits the enclosed response to the Federal Energy Regulatory Commission's ("Commission" or "FERC") letter requesting further information issued on September 21, 2023, in the above-referenced docket. This submittal supplements the filing the New York Independent System Operator, Inc. ("NYISO") made on Central Hudson's behalf on July 28, 2023.

I. Background

On July 28, 2023, the NYISO filed on behalf of Applicant and pursuant to Federal Power Act Section 205 and Part 35.13 of the Commission's regulations, proposed revisions to the NYISO Open Access Transmission Tariff ("OATT"). Those revisions are to establish Central Hudson's formula rate template and associated implementation protocols (together "Formula Rate"), and to derive and recover the costs of eligible transmission projects identified and designated under Rate Schedule 19 of the NYISO OATT, as explained further in the submittal. On September 21, 2023, the Commission issued a deficiency letter requesting additional information concerning the Applicant's filing.

The burden of demonstrating that the proposed tariff amendments are just and reasonable rests with Central Hudson. The NYISO takes no position on any substantive aspect of this filing. Unless otherwise defined herein, capitalized terms used herein have the meanings ascribed to them in the NYISO OATT.
