

NYISO Proposed Variations from Order No. 2023 Revisions to Commission's Pro Forma Interconnection Procedures and Agreements

The Commission directed transmission providers to offer an item-by-item justification of each variation from the pro forma provisions that were modified in Order No. 2023. The NYISO provides the below table detailing its proposed revisions from the changes to the Commission's *pro forma* interconnection procedures and agreements adopted in Order No. 2023 and Order No. 2023. A, with reference to the additional detail included in the cover letter. For purposes of the table, the NYISO did not reference the edits in the Commission's order to remove the word "the" before transmission provider or interconnection customer, to add "of this LGIP" to cross references, to lowercase the terms section or article, to update internal cross references, or to spell out numbers of days and capitalize, as applicable, calendar or business days.
