### Re: Docket No. ER24-1915-000; Ministerial Correction to Proposed Tariff Revisions

Dear Ms. Reese:

On May 1, 2024, the New York Independent System Operator, Inc. ("NYISO") submitted tariff revisions to its Open Access Transmission Tariff ("OATT") and its Market Administration and Control Area Services Tariff ("Services Tariff") to comply with the Commission's Order Nos. 2023 and 2023-A ("Compliance Filing").<sup>1</sup> The NYISO requested that its proposed tariff revisions have an effective date of May 2, 2024.

The as-filed clean and redline versions of Section 32.5 of the OATT that were included in the Compliance Filing inadvertently omitted tariff revisions that the NYISO previously proposed in Docket No. ER24-951-000.<sup>2</sup> The Commission accepted these tariff changes on March 19, 2024, with an effective date of March 20, 2024.<sup>3</sup> These tariff revisions therefore became effective prior to the requested effective date for the tariff revisions in the Compliance Filing.

The NYISO submits this errata to correct the version of Section 32.5 that the NYISO proposes to revise in its Compliance Filing by adding the changes to Section 32.5 that the Commission accepted in Docket No. ER24-951-000 to the version of Section 32.5 included with the Compliance Filing. The NYISO does not propose in this filing any new substantive revisions to Section 32.5, but simply to correct the underlying base tariff language that it proposes to revise in the Compliance Filing.

2. A corrected blacklined version of the NYISO's OATT Section 32.5 that includes the omitted text, identifying in redline format only the NYISO's proposed revisions to this section included in the Compliance Filing (Attachment II).

# II. <u>Proposed Effective Date</u>

In its Compliance Filing, the NYISO requested an effective date for its proposed tariff revisions of May 2, 2024. In addition, the Combined Notice of Filings #1 issued by the Commission on May 2, 2024 established a comment deadline of 5 pm ET on May 22, 2024. Because this filing merely corrects a ministerial error and has no substantive impact on the Compliance Filing or the proposed tariff revisions submitted therewith, the NYISO respectfully requests that: (i) its previously requested effective date (i.e., May 2, 2024) be retained, and (ii) the Commission's previously established comment deadline remain unaltered.
