**Re: Central Hudson Gas and Electric Corporation, Docket No. ER23-2507
Settlement Order Compliance Filing**

Dear Secretary Reese:

In accordance with the Federal Energy Regulatory Commission’s (“Commission” or “FERC”)¹ Letter Order issued November 8, 2024 in the above-referenced proceeding approving the Joint Offer of Settlement on Rate Schedule 19 submitted August 20, 2024 (“Rate Schedule 19 Settlement”),² Central Hudson Gas and Electric Corporation (“Central Hudson”) respectfully submits this compliance filing to reflect certain revisions to its formula rate template related to the ceiling return on equity (“ROE”) value for Rate Schedule 19 projects, as well clarify that Schedule 19 projects are not eligible for ROE incentive adders.

This compliance filing modifies Central Hudson’s formula rate template contained in Section 6.19.9.2.2 of Attachment 4 to Rate Schedule 19 (“Formula Rate Template”) to reflect the ceiling ROE value set forth in Article 3.2(a) of the Settlement for Rate Schedule 19 projects on Workpaper 6-Project Cost of Capital. This compliance filing also includes a new Note O on Appendix A of the Formula Rate Template that clarifies that Schedule 19 projects are not eligible for ROE incentive adders, as stated in Article 3.2(b) of the Settlement. These revisions ensure consistency with the Settlement.

Background and Description of Filing

On July 28, 2023, as amended on October 23, 2023, the NYISO submitted, on behalf of Central Hudson, proposed revisions to the NYISO OATT in Docket No. ER23-2507. These revisions included Central Hudson's formula rate template, associated formula rate implementation protocols, and conforming tariff amendments to enable the derivation and recovery of costs for eligible transmission projects under Rate Schedule 19³ of the OATT. Central Hudson also requested a ROE ceiling value for Rate Schedule 19.

On December 22, 2023, the Commission issued an order conditionally accepting Central Hudson's filing.⁴ The Commission approved the formula rate protocols and tariff amendments effective September 27, 2023, but subjected the formula rate template to further compliance and suspended its effectiveness for a nominal period, subject to refund and pending hearing and settlement judge procedures.⁵ Consolidated Edison Company of New York filed a Joint Offer of Settlement addressing ceiling ROE proposals under Rate Schedule 19, including the ceiling ROE for Central Hudson's formula rate.⁶

On September 27, 2024, the Settlement Judge certified the Rate Schedule 19 Settlement to the Commission as an uncontested settlement.⁷ On November 8, 2024, the Commission issued the Settlement Order approving the Settlement.⁸ The Settlement Order directed Central Hudson to make compliance filings for its formula rate template, including the following requirements:⁹

- Rate Schedule 19: Central Hudson must incorporate the ceiling ROE value for Rate Schedule 19 projects set forth in Appendix A-2 of the Rate Schedule 19 Settlement as reflected by revisions to Lines 2, 6, 10, and 14 on "Workpaper 6: Project Cost of Capital." Central Hudson also needs to clarify that Schedule 19 projects are not eligible for ROE Incentives, per Article 3.2(b) of the Rate Schedule 19 Settlement.
