Dear Secretary Reese:

On December 3, 2024, the New York Independent System Operator, Inc. (“NYISO”) filed with the Federal Energy Regulatory Commission (“Commission”), a Notice of Cancellation of the Engineering, Procurement, and Construction Agreement (“EPC Agreement”) for a System Deliverability Upgrade located on the Long Island Lighting Company d/b/a LIPA’s transmission system. The EPC Agreement is designated as Service Agreement No. 2776 under the NYISO’s Open Access Transmission Tariff.

The NYISO submits this filing to supplement the record to correct the requested date for the cancellation of the EPC Agreement to become effective (i.e., the day after the end of the statutory 60-day notice period). The December 3 filing inadvertently indicated that the day after the end of the 60-day notice period is February 3, 2024. The NYISO supplements the record to correct this date to February 3, 2025.
