Dear Secretary Reese:

In accordance with the Federal Energy Regulatory Commission's ("Commission" or "FERC")¹ Letter Order issued December 19, 2024 in the above-referenced proceeding approving Orange and Rockland Utilities, Inc. ("O&R") Joint Offer of Settlement ("Settlement"),² O&R respectfully submits this compliance filing to reflect certain revisions to its formula rate template related to the return on equity ("ROE") for Rate Schedule 10 and Rate Schedule 19 projects, as well as to remove references to ROE incentive adders, as specified in Article 3.2(b) of the Settlement approved by the Commission.

This compliance filing modifies O&R's formula rate template contained in Section 6.19.10.2.2 of Attachment 5 to Rate Schedule 19 of the NYISO OATT ("Formula Rate Template") to reflect the respective ROE values set forth in the Settlement for Rate Schedule 10 and Rate Schedule 19 projects. This compliance filing also modifies the Formula Rate Template to remove references to prohibited incentive adders from Line 12 and Note C of Workpaper 10b10 and adds a Note Q on Appendix A to state that Rate Schedule 19 projects are not eligible for ROE incentive adders. These revisions ensure consistency with the Settlement concerning ROE incentive adders for Rate Schedule 10 and Rate Schedule 19 projects.

Background and Description of Filing

On March 25, 2024, the NYISO submitted on behalf of O&R proposed revisions to the NYISO OATT in Docket No. ER24-1614. These revisions included O&R's Formula Rate Template, associated formula rate protocols, and conforming tariff amendments to enable the derivation and recovery of costs for eligible transmission projects under NYISO OATT Rate Schedule 10³ and Rate Schedule 19.⁴ O&R also requested an ROE ceiling value for Rate Schedule 19 and a base ROE for Rate Schedule 10 and sought a 50-basis point ROE adder for participation in a Regional Transmission Organization ("RTO Participation Adder") for Rate Schedule 10.

On May 24, 2024, the Commission issued an order conditionally accepting O&R's filing.⁵ The Commission: (1) accepted O&R's proposed Attachment 5 to Rate Schedule 19, which includes the formula rate protocols; (2) accepted the proposed Attachment 5 to Rate Schedule 10; (3) accepted the proposed formula rate template, subject to refund and to hearing and settlement judge procedures on the proposed ROEs for projects under Rate Schedule 10 and projects under Rate Schedule 19; and (4) conditionally granted the 50-basis-point RTO Participation Adder for Rate Schedule 10 for filing, subject to the outcome of paper hearing procedures.⁶

On September 20, 2024, O&R filed the Settlement among O&R, the New York State Public Service Commission, the New York Association of Public Power, and the New Jersey Division of Rate Counsel addressing the ROE values applied under O&R's formula rate template. On October 15, 2024, the Settlement Judge certified the Settlement to the Commission as an uncontested settlement. On December 19, 2024, the Commission issued an Order approving the Settlement. The Settlement Order directed O&R to make a compliance filing for its Formula Rate Templates under both Rate Schedule 10 and Rate Schedule 19, including the following requirements: 10

- Rate Schedule 10: O&R shall remove references in O&R's Formula Rate Template to any ROE incentive adders that are prohibited by Article 3.2(b) of the Settlement, such as Line 12 and Note C on "Workpaper 10b10: Schedule 10 Project ATRRs."
- Rate Schedule 10 and 19: O&R shall revise its formula rate template and associated tariff records to fully implement the terms of the Settlement. These revisions must ensure that the tariff reflects the approved ROE framework and does not include any disallowed incentive adders.

The NYISO has confirmed to O&R that it will send an electronic link to this filing to the official representative of each of its customers and each participant on its stakeholder committees.

Conclusion

O&R was directed by the Commission to submit a compliance filing for these revisions in eTariff format within 30 days of the Settlement Order. This compliance filing, therefore, ensures alignment with FERC's directives and the approved Settlement for Rate Schedule 10 and Rate Schedule 19.
