Re: *New York Independent System Operator, Inc.*, Notice Establishing Effective Date for Tariff Revisions Developed to Enhance the Way Fast-Start Resources are Scheduled in the Day-Ahead Market; Docket No. ER24-1655-000

Dear Secretary Reese,

Consistent with the New York Independent System Operator, Inc.'s ("NYISO's") March 29, 2024 Federal Power Act Section 205¹ filing in this proceeding (the "Fast-Start Resource Filing"), the Letter Order issued pursuant to delegated authority on May 29, 2024 accepting the NYISO's proposed Tariff revisions,² and the Orders Granting Deferral of Effective Date and Waiver Request,³ the NYISO submits this notice informing the Federal Energy Regulatory Commission ("Commission") and its stakeholders that it intends to make the Tariff revisions that enhance the way Fast-Start Resources are scheduled in the Day-Ahead Market effective on March 18, 2025.⁴ The Tariff revisions that will become effective on March 18, 2025 are set forth in Attachments III through IV to the Fast-Start Resource Filing.

The NYISO has determined that the Tariff revisions submitted with the Fast-Start Resource Filing, and accepted by the Commission, need to be conformed to address subsequent Commission decisions in other Dockets, and the timing of the NYISO's implementation of those accepted Tariff revisions. Attachment A to this Effective Date Notice provides a redline of Market Services Tariff Section 17.1 that incorporates changes that were accepted by the Commission and made effective after the NYISO submitted its Fast-Start Resource Filing.

The Commission granted the NYISO's request to defer the effective date of these Fast-Start Resource Tariff revisions in this docket on December 31, 2024.

II. Notice of Effective Date for Tariff Revisions Expanding Range of Resource Types that May Participate as Co-located Storage Resources

In compliance with the December Deferral Order, the NYISO hereby provides notice that it intends to implement the accepted revisions implementing the Tariff revisions set forth in Attachments III through IV to the Fast-Start Resource Filing on March 18, 2025.

Submitting this notice now complies with the directive in the December Deferral Order that the NYISO provide at least two weeks prior notice of the actual effective date for the Tariff revisions accepted in this proceeding.

III. Service

The NYISO will send an electronic copy of this filing to the official representative of each party to this proceeding, to the New York Public Service Commission, and to the New Jersey Board of Public Utilities. In addition, a complete copy of this filing will be posted on the NYISO's website at www.nyiso.com, and the NYISO will send an electronic link to this filing to the official representative of each of its customers and to each participant on its stakeholder committees.

IV. Conclusion

The NYISO respectfully requests that the Commission update its records to reflect a March 18, 2025 effective date for the tariff revisions referenced herein.
