Re: New York Independent System Operator, Inc., First Informational Report Addressing NYISO Progress on EMS/BMS Upgrade and Implementing Order No. 881 Compliance Plan; Docket No. ER22-2350-00\_

# Dear Secretary Reese:

In accordance with the Federal Energy Regulatory Commission's ("Commission") March 29, 2024, *Letter Order*, the New York Independent System Operator, Inc. ("NYISO") submits this informational filing updating the Commission on the NYISO's efforts to complete its Energy Management System ("EMS") and Business Management System ("BMS") (collectively "EMS/BMS") upgrade and to implement its Order No. 881 compliance plan.

#### I. Informational Filing

The NYISO made significant progress on the EMS/BMS upgrade project throughout 2024. First, new hardware was installed, and the upgraded operating system was installed in all NYISO's development, testing, and production environments to prepare for deployment of the updated Network Manager ("NM") platform.<sup>2</sup> Second, with the new hardware and new operating system in place, the NYISO undertook the first phase of testing of the updated NM software, known as Factory Acceptance Testing. This Factory Acceptance Testing was successfully completed in December. Factory Acceptance Testing validated that the core functions of the system operated as expected on the upgraded hardware by executing functional tests with the vendors staged data. In the first quarter of 2025 the NYISO installed the software in its test environment and began testing with the NYISO's data.

The NYISO is on track to fully deploy the NM platform upgrade in 2025. Throughout this year, the NYISO plans to complete the rest of the testing phases. Two phases are yet to be undertaken: quality assurance and user acceptance testing. After completion of the remaining testing, the NYISO expects to deploy the upgrade in the fourth quarter of 2025.

After deploying the EMS/BMS technologies upgrade project, the NYISO will return to the software development activities necessary to implement its Order No. 881 compliance plan.
