Re: New York Independent System Operator, Inc., Compliance Filing; Docket No. ER25-1462-00

Dear Secretary Reese:

On February 28, 2025, the New York Independent Operator, Inc. ("NYISO") submitted proposed revisions to its Open Access Transmission Tariff ("OATT") and Market Administration and Control Area Services Tariff ("Services Tariff") to govern the NYISO's collection and allocation of its costs related to the potential imposition of duties on imports of electrical energy from Canada ("February 2025 Filing"). The proposed revisions also authorized the NYISO to make necessary adjustments to customer credit requirements as needed to address ad valorem rate of import duty-related costs. The Commission accepted the NYISO's proposed tariff revisions, subject to condition, in an April 14, 2025 Order ("April 2025 Order"). The Commission directed the NYISO to submit a compliance filing with revised tariff records incorporating the New York Transmission Owners' ("NYTOs") proposed revisions and removing proposed provisions establishing the "Alternative Cost Allocation Method." The NYISO submits this filing in compliance with the April 2025 Order.

## I. BACKGROUND

In the February 2025 Filing, the NYISO proposed tariff revisions to (i) establish a Preferred Cost Allocation Method providing for the collection and allocation of import duty costs incurred by the NYISO; (ii) adopt an Alternative Cost Allocation Method that could be used if the Preferred Cost Allocation Method were rejected; and (iii) authorize the NYISO to adjust credit requirements to account for any additional financial risks corresponding to import duties.

The NYISO proposed that the tariff revisions be accepted under section 206 of the Federal Power Act ("FPA")<sup>4</sup> and made effective on February 28, 2025, or alternatively, be accepted under FPA section 205 and made effective on March 1, 2025.<sup>5</sup>

On March 13, 2025, the NYTOs submitted comments on the February 2025 Filing, requesting that the NYISO add language to OATT sections 6.22.2 and .3 to allow the NYISO to calculate payment amounts on import duties according to federal regulation or guidance governing the calculation of potential import duties on Canadian electricity, if any, that differed from the proposed Preferred Cost Allocation Method.<sup>6</sup> The NYISO had informed the NYTOs that it consented to this modification.

Consistent with the Commission's directive in the April 2025 Order, the NYISO submits this compliance filing and proposed tariff revisions to incorporate the NYTOs' proposed revisions and remove the Alternative Cost Allocation Method provisions.

#### II. PROPOSED TARIFF REVISIONS

In this filing, the NYISO submits proposed revisions to Rate Schedule 22 to the NYISO OATT. The proposed revisions to sections 6.22.2 and .3 incorporate the sentence proposed by the NYTOs to provide that the NYISO shall calculate payment amounts on import duties according to any federal regulation or guidance governing the calculation of potential import duties on Canadian electricity if it differs from the Preferred Cost Allocation method. The proposed deletion of section 6.22.4 removes the Alternative Cost Allocation Method.<sup>7</sup> The NYISO is also renumbering subsequent subsections to reflect the deletion of the current section 6.22.4.

## III. EFFECTIVE DATE

In the February 2025 Filing, the NYISO proposed an effective date of February 28, 2025 if the Commission acted under section 206, or, alternatively, an effective date of March 1, 2025 if the Commission acted under section 205.<sup>8</sup> In the April 2025 Order, the Commission accepted the proposed OATT and Services Tariff revisions under FPA section 205, to be effective March 1, 2025, subject to the NYISO's submittal of the instant compliance filing.<sup>9</sup> The NYISO, therefore, requests that the Commission accept its proposed compliance revisions to Rate Schedule 22 to become effective on March 1, 2025.
