Dear Ms. Bose:

On August 30, 2010 the New York Independent System Operator, Inc. ("NYISO") filed a request to withdraw its August 16, 2010 compliance filing ("August 16 Filing"), which was in response to the Federal Energy Regulatory Commission's July 13, 2010 Order<sup>1</sup> directing modifications to Attachment Y of the NYISO's Open Access Transmission Tariff. The NYISO requested withdrawal of the August 16 Filing because it originally submitted the filing under an incorrect filing type code.

In this filing the NYISO is resubmitting its August 16 Filing, in its entirety, under the correct filing type code (Code 80).<sup>2</sup>
