Re: New York Independent System Operator, Inc., Docket No. ER13-2016-000, Notice of Delayed Implementation of Real-Time Guarantee Payment Mitigation Software for Regulation Capacity and Regulation Movement Bids

Dear Secretary Bose:

On July 23, 2013, the New York Independent System Operator, Inc. ("NYISO") requested a temporary, limited waiver of Sections 23.3.3.1.1 and 23.3.3.1.2 of (Attachment H to) its Market Services Tariff ("Waiver Request").¹ The Federal Energy Regulatory Commission ("Commission" or "FERC") issued an order granting the NYISO's Waiver Request on August 22, 2013 ("August Order").² On October 4, 2013, the NYISO requested a twenty-two day extension of the temporary, limited waiver that the Commission granted in its August Order, from October 23, 2013 to November 14, 2013 ("Waiver Request Extension"). On October 24, 2013, the Commission issued a notice extending the waiver period until November 14, 2013.³

On October 22, 2013, the NYISO notified the Commission and Market Participants that it would incorporate Regulation Capacity and Regulation Movement Bids and reference levels into the real-time guarantee payment ("RTGP") mitigation software on October 30, 2013. During the preparation for deployment, an IT infrastructure hardware issue was identified that could be exacerbated by the major software deployment that was scheduled for October 30, 2013. The NYISO is working with its hardware vendor to develop a timely solution. Therefore, the NYISO has delayed the deployment of its bundled software package that was scheduled for October 30, 2013.

The NYISO intends to deploy the RTGP mitigation software improvements on or before the November 14, 2013 expiration of the Waiver Request Extension as long as the IT infrastructure hardware issue is resolved.⁴ The NYISO will implement the RTGP mitigation software improvements as soon as they are deployed to production. The NYISO renews its commitment to provide notice to the Commission and to its Market Participants at least one week prior to implementing the software improvements that are necessary to incorporate Regulation Capacity and Regulation Movement Bids and reference levels into the NYISO's RTGP mitigation software.⁵

The NYISO will send an electronic link to this filing to the official representative of each of its customers, to each participant on its stakeholder committees, to the New York Public Service Commission, to all parties listed on the Commission's official service list in Docket Nos. ER12-1653 and ER13-2016 and to the New Jersey Board of Public Utilities. In addition, the complete filing will be posted on the NYISO's website at <u>www.nyiso.com</u>.
