Dear Secretary Bose:

Pursuant to Section 35.15 of the Federal Energy Regulatory Commission's ("Commission") regulations,<sup>1</sup> Niagara Mohawk Power Corporation d/b/a National Grid ("Niagara Mohawk") submits for Commission acceptance this Notice of Cancellation of the Cost Reimbursement Agreement ("Reimbursement Agreement") between Niagara Mohawk and Athens Generating Company, LLC ("Athens").<sup>2</sup> The Reimbursement Agreement is being cancelled because performance has been completed and final performance has been made under the Reimbursement Agreement.

Niagara Mohawk requests that the Commission accept this Notice of Cancellation effective 61 days after the date of this filing, *i.e.*, June 9, 2015.

## **I. Background and Justification for Cancellation**

The Reimbursement Agreement went into effect as of November 18, 2011.<sup>3</sup> Section 2.1 of the Reimbursement Agreement states that it will remain in effect until performance has been completed and final payment has been made as contemplated by the Reimbursement Agreement. Performance has been completed and final payment has been made.
